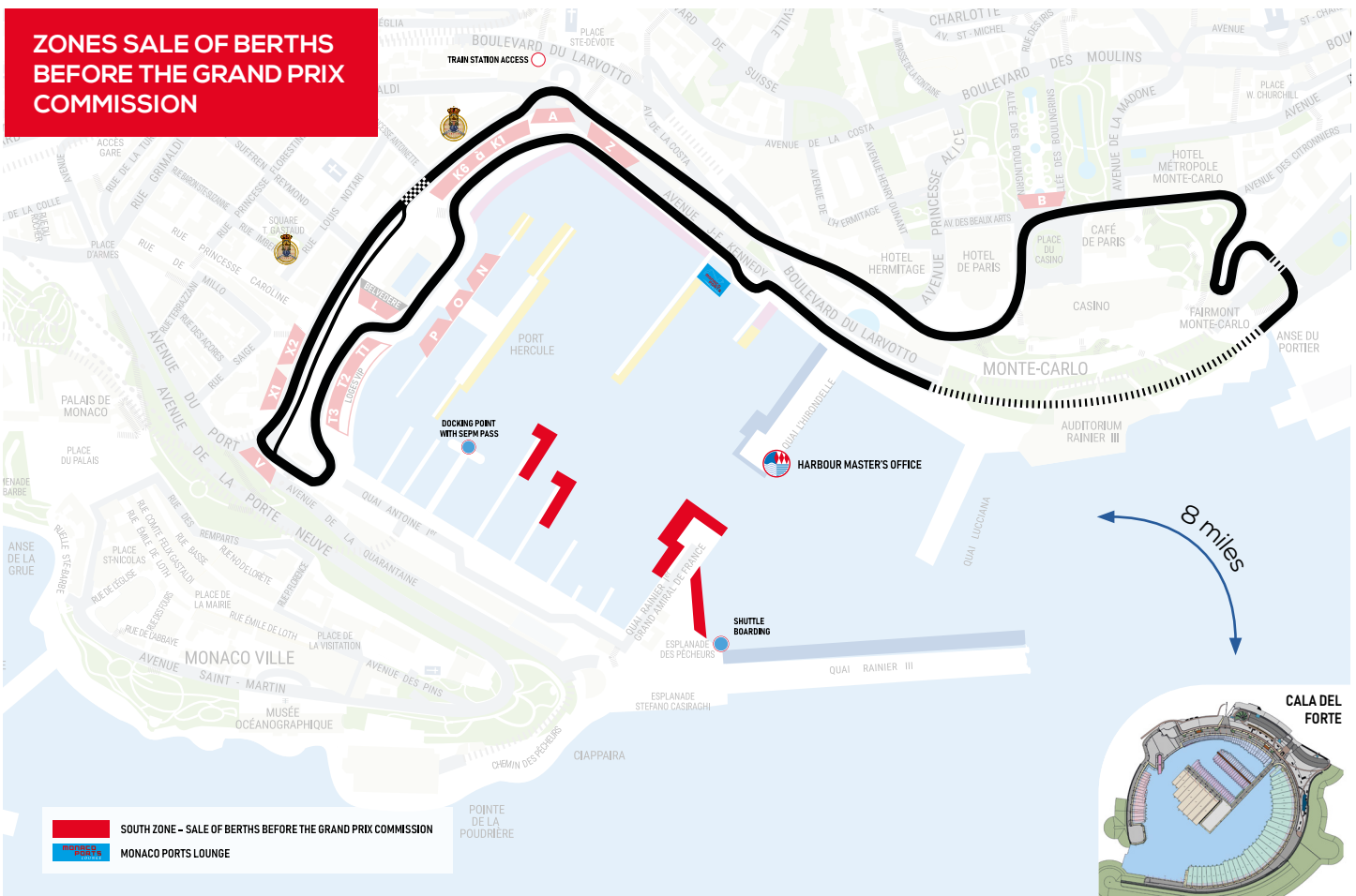

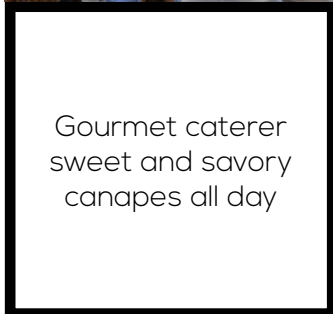

**SEPM TICKETS FOR THE MONACO GRAND PRIX
GENERAL TERMS AND CONDITIONS OF SALE (THE «GTCS»)**

1. The purchase of an entry package entitling the holder to occupy a seat made available by the Société d'Exploitation des Ports de Monaco (hereinafter the «SEPM») in the Monaco Ports Lounge on the occasion of the Monaco Grand Prix (hereinafter the «Ticket(s)») implies acceptance of the provisions below. No other special condition may take precedence over these GTC. Any condition to the contrary, in particular any condition of purchase, shall be unenforceable.
2. The allocation of space is at the discretion of the SEPM and cannot be contested.
3. The Tickets will not be taken back, exchanged or refunded. The Tickets will not benefit from a right of withdrawal. All purchases are therefore firm and final.
4. The Ticket is only valid for the date indicated on it. It will be electronically checked at the entrance to the site, presented at the exit, and must then be presented at any security check.
5. Any invoice issued for the purchase of one or more Tickets will be made out exclusively in the name of the purchaser.
6. Only the purchase of a ticket from the SEPM guarantees its validity. Ticket resale is prohibited unless expressly authorised by SEPM.
7. All tickets will be attached to a yacht that is a client of the Ports of Monaco. Each yacht having purchased tickets will declare to SEPM the list of persons likely to use them. Checks will be carried out which may result in access being denied.
8. The Tickets will be distributed the week of the Grand Prix, i.e. from Monday 1 June 2026, to boats present in the ports of Monaco and Cala del Forte. In the event of cancellation by the boat, no ticket will be refunded.
9. Any person may be required to undergo a security check at the entrance to the site and be asked to show any objects they are carrying. Access may be refused to any person who does not agree to undergo this security check, without the right to claim any refund. It is strictly forbidden to bring in any object that could be a weapon, a projectile or a danger to people.
10. The photographs and visuals of the site shown on the presentation brochure are not contractual in nature. SEPM cannot therefore be held liable if the characteristics differ from the visuals on the presentation brochure, even if the latter are incorrect or incomplete.
11. The Ticket holder authorises SEPM to use the images taken on the site and in which he/she may appear, in order to reproduce them in any medium, including documents that SEPM may publish to promote and/or advertise the event as well as the broadcasts of the Monaco Grand Prix, throughout the world.
12. Animals are not allowed inside.
13. SEPM is responsible for processing the personal data transmitted when a Ticket(s) is purchased, in compliance with the legislation in force relating to the protection of personal information. The collection of personal or nominative information by SEPM is strictly limited to the needs of the services offered. Any person who has purchased one or more ticket(s) has the right to access, modify, rectify and delete any personal information concerning them. To exercise this right, the request must be sent by post to the SEPM head office (30, quai l'Hirondelle, Monaco (98000)), for the attention of the person responsible for processing or his/her representative.
14. The minimum age for access to the Monaco Ports Lounge is 8.
15. Cancellation by SEPM and limitation of liability: In the event of the official cancellation of the Grand Prix or the holding of events behind closed doors or any other circumstance preventing the availability of all or part of the Monaco Ports Lounge, SEPM undertakes solely to refund tickets already paid for. No other form of indemnity or compensation may be requested from SEPM in this respect, on any grounds whatsoever.

SEPM's liability under this contract shall in no event exceed the price of the tickets, to the exclusion of all other damages, whatever the cause.
16. These general terms and conditions of sale may be amended in accordance with any government decisions that may be imposed on SEPM.

The applicable law is Monegasque law and any difficulty relating to the interpretation or execution of these GCS will fall within the jurisdiction of the Monegasque courts, regardless of the place of execution of these GCS or the domicile of the defendant.
